Tenure: 89 days or till the regular incumbents join, whichever is earlier.

Pay Scale : Basic pay Rs. 67000/- plus usual allowances as admissible under the rules

Essential Qualifications / Eligibility :


- I. MBBS with PG Degree in Physiology from recognised University .
- II. **DMC Registration** must be having valid DMC Registration at the time of interview .

Age Limit: Upper age limit for eligibility will be 33 years as on date of interview i.e. on 13th September 2018. However, if no suitable/eligible candidates are available, then 40 years age (in accordance of circular no. F.121/26/2010/H&FW/1996-2045 dated 10/06/2011 issued by H&FW department, Govt. of NCT of Delhi) may be considered. Age limit is relaxable for SC/ST candidates by 5 years and for OBC candidates by 3 years.

How to Apply: Suitable and desirous candidates fulfilling educational qualification/eligibility conditions should appear for a **Walk-in-Interview** with their application along with original certificates and one set of attested photocopies of

the relevant documents in support of Age, Qualification, Attempts, Mark sheet., Degree, DMC Registration, Category & Experience certificate etc. and two passport size photographs. 
